## BIOGRAPHICAL SKETCH

John R. Palmer (b. ca 1838) enlisted in Company K., 11<sup>th</sup> Indiana Regiment in August, 1861. His residence at that time was listed as Johnson County, Indiana. In December, 1864, he was promoted to Captain and was mustered out in July, 1865.
